



**Minutes of the Third General Body Meeting of the Council
held on 30th May 2015 at 12.15 p.m at Hotel Naoba,**

The President Welcome all the members and call the meeting to order. The agenda were taken up one by one and the following resolutions were drawn unanimously.

1. The brief activity repost submitted by the Registrar was approved, with the rectification of Primary registered members as 192, additional qualification members as 78 and NOC as 16.
2. The no objection certificate to be produced by a doctor to be produced at the time of registration, if he/she was registered earlier to other medical council will not be mendatory.As it was incorporated as a rule of the council, the Council cannot delete it, unless it is modified by the Government with a resolution of the State Assembly. The Registrar is advised by the council to be silent on the issue as it makes things complicated in the process of registration.
3. The Council decided to explore the means of opening an examination centre under our supervision or otherwise, to conduct eligibility/qualifying examination being

- conducted by the NBE, New Delhi, at Imphal for the Graduate passed out foreign trained medical graduates and Indian trained DNB students of various specialities.
4. Decided to depute a member of our council as MCI representative (one entitled for our council) by election .Registrar will notify accordingly inviting willing candidates from the registered members ofMMC, for nomination and election via press .They will submit the nomination paper with valid proposing and seconding by two different registered members of the council. Election will be held in a month's time from the date of publication of notification.
 5. Decided to conduct mass campaign to all the Modern medicine practitioners in Manipur to get themselves registered on time or face the consequences of the MMC Acts and Rules. If necessary registration camps may be organised at various institutions.
 6. Decided to activate the various activities of the Standing committees of the Council.

A) CME and accreditation committee is effective and complimented.

B) On 13th June there is a proposal of conducting a CME on ""QUALITY ASSURANCE SERVICES"" at Imphal where Dr. Th. Dhabali is the local co-ordinator. Chairman and Convenor of Medical Ethics committee will collaborate with Dr. Th. Dhabali,so as MMC Can be a partner or associate with the CME and campaign for the mass involvement Doctors of our State.

C) Public relation committee chaired by the President is empowered to co-opt necessary members of the council for effective implementation of the functioning of the committee. The committee is entrusted:

i) To Pursue the issue of the Proposed bill submitted by the Council to the Government on ""The Manipur Medicare Services Personnel and Medicare Services Institutions prevention of violence and damage to property Bill/Act"".

ii) The committee will arrange a public dialogue regarding Doctor- Patient relation. Modalities were entrusted to the Chairman. The Registrar will collaborate.

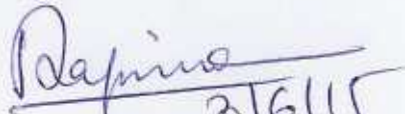
7. Decided to pursue with the Government of the already proposed issues of the Council Like a Permanent office building of the Council, enhancement of Honorarium of the Council members, recurring annual grants. The President will lead the activities.
8. Decided to write to Dr.O.Ibomcha Sing,DHS, Govt.of Manipur to surrender his regular seat of being the member of the Council, as he is also the ex-officio member of the council by virtue of his official designation. Thus the council may be benefited by inducting another member with the notification by the Government. He may also be reminded that he can be disqualified under Acts and Rules of the Council to be the regular member of council as he had failed to attend the Council meeting on four consecutive occasions. The president will write accordingly.
9. Decided to Propose to the Government to Amend the Council Act by inducting two members of the Council from JNIMS.

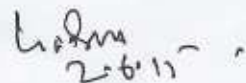

 12. The Present Registrar of the Council Dr. Karam Lokendro, will be retiring from service attaining the age of superannuation on 31st August 2015. The council decided and to recommend to the Government for continuation of his services as the Registrar of the Council for another two years which is permitted by the Rules of the Council. The President will write to the Government for his service extension as the Registrar of the Council.
 13. To Develop an Identity card of the Council for its registered members.
