Election to the Manipur Medical Council

**NOTIFICATION**

Imphal, the 1<sup>st</sup> October, 2024

No.MNMC-E(1)/2014-27 : It is hereby notified to all concerned that there will be an election to fill up the 8 (eight) vacant posts of Members of the Manipur Medical Council (MNMC) from amongst the Registered Medical Practitioners of MNMC for the period of one term *i.e.* 5 (five) years.

2. Nomination form : Any Registered Medical Practitioner under MNMC qualified to stand for election under Section 3 of the Manipur Medical Council Act may be nominated as a candidate and such nomination will be made by means of a nomination paper (Form 8), which will be supplied to any elector who may apply for the same.
3. Nomination fee : Each candidate willing to stand for the election will pay to the Registrar a fee of Rs.1000/- by crossed bank draft from a nationalised bank in favour of the "Manipur Medical Council" payable at Imphal. The said fee is non-refundable.
4. Nomination of candidate : Each candidate's name will be proposed by any two members of the Registered Medical Practitioner, one as the proposer and the other as the seconder who will duly complete and sign the prescribed nomination form. The nominated candidate himself/herself will also subscribe in the nomination form which will indicate his/her consent to the nomination.
5. Receipt of nomination paper : The completed nomination paper will be received up to 4:00 p.m of 30th October, 2024 at the Office of the Registrar, Manipur Medical Council, Lamphelpat (Medical Directorate Complex).
6. Scrutiny of nomination paper : Scrutiny will be done on 31<sup>st</sup> October, 2024 at 2:00 p.m at the Office of the Registrar, Manipur Medical Council, Lamphelpat (Medical Directorate Complex).

7. Withdrawal of candidature : The last date for withdrawal of candidature is up to 4:00 p.m of 4<sup>th</sup> November, 2024.

Candidate may withdraw his/her candidature by notice in writing delivered to the R.O within the above time period.

8. Polling : Polling, if necessary will be carried out on 5<sup>th</sup> November, 2024 from 10:00 a.m to 3:00 p.m at the Office of the Registrar, Manipur Medical Council, Lamphelpat (Medical Directorate Complex).

If the number of contesting candidates does not exceed the number of vacancies to be filled in, the R.O will forthwith declare such candidates as duly elected to fill such vacancies without any polling. When the number of candidates exceed the number of members to be elected, the R.O will conduct the election within the above stipulated time.


9. Scrutiny and counting : Scrutiny and counting of vote will be done on 5<sup>th</sup> November, 2024 from 3:30 p.m onwards at the Office of the Registrar, Manipur Medical Council, Lamphelpat (Medical Directorate Complex).

A candidate and not more than one representative, duly authorised by him/her may remain present at the time of counting votes. The R.O can reject a ballot if it is not properly filled or completed. All the ballot papers other than those received late or rejected will be mixed together and then scrutinized and the valid vote counted.

10. Declaration of election results :

After counting of votes is completed the R.O will declare the result of election. If there is an equal number of votes in favour of two or more candidates for one vacancy the election will be determined by the R.O by a draw of lots in the presence of the candidates or their representatives.
